



2010 FORMULA 1 QANTAS AUSTRALIAN GRAND PRIX & 2UE Pit Canopy Competition

Terms and Conditions.

1. Information on how to enter and prizes form part of these conditions.

3. The promotion period begins on Monday 1st of March at 5.30am and ends by 9am on Friday 12th March, 2010.
4. Entry is open to Australian residents only and entry is deemed as acknowledgement and acceptance of Conditions of Entry.
5. Fairfax Radio employees, their immediate families and any agencies associated with this promotion including, Australian Grand Prix Corporation (**AGPC**) employees, Qantas and associated prize suppliers are excluded from entry.
